The employed employee will be responsible for conducting research and teaching activities. He will actively participate in the organizational work of the Faculty |

INFORMATION CLAUSE

Zgodnie z art. 13 ogólnego rozporządzenia o ochronie danych osobowych z dnia 27 kwietnia 2016 r. (Dz. Urz. 3. Your personal data will be processed:
 - 1) for the purposes of currently announced recruitment - pursuant to sec. 6. 1 letter b of the general Regulation on the protection of personal data of April 27, 2016 and the Labor Code of June 26, 1974 in order to conclude a contract,
 - 2) future recruitments if you grant your consent pursuant to sec. 6. 1 letter a of the Regulation, expressed in writing for the period specified in the declaration of consent
4. Your personal data, if the contract is not concluded, will be stored for a period of up to 6 months or the period specified in the declaration of consent,
5. The recipients of your personal data will only be entities authorized to obtain personal data under the law and entities cooperating in the recruitment process, your data will not be transferred to a third country, except in cases resulting from your express request,
6. You have the right to request from the administrator access to your personal data, the right to request their rectification, deletion or limitation of processing, the right to object to the processing, the right to transfer data, and if consent is granted, the right to withdraw it at any time,
7. Providing personal data for ongoing recruitment is a statutory requirement of the Labor Law. The consequence of not providing data is exclusion from recruitment.
8. Providing personal data for future recruitment purposes is voluntary and does not affect the course and results of ongoing recruitment.
