## **Rules of Using the Student Recreation Zone in Student Dormitory F2**

### **§ 1.**

1. This ordinance sets out the rules for using the Student Recreation Zone in the F2 Student Dormitory, hereinafter referred to as the "Zone."

2. Persons present in the Zone are required to familiarize themselves with this ordinance, comply with its provisions, and observe general health and safety regulations, fire protection rules, and the regulations of the Student Dormitory.

3. Entry into the Zone constitutes acceptance of the rules set forth in this ordinance.

4. The premises of the Student Dormitory are monitored.

### **§ 2**

1. The Zone is available from 12:00 PM to 9:00 PM. The management of the Student Dormitory reserves the right to change the opening hours or temporarily close the Zone on specific days in justified cases.

2. The following individuals are authorized to use the Zone:

- 1) residents of Student Dormitories F1 and F2 of Bydgoszcz University of Science and Technology;
- 2) students and PhD students of Bydgoszcz University of Science and Technology;
- 3) guests of student dormitory residents, including non-students of Bydgoszcz University of Science and Technology, who are registered on the visitor list in accordance with the Student Dormitory regulations;
- 4) employees of Bydgoszcz University of Science and Technology.

3. Individuals who are not residents of the F2 Student Dormitory and who have registered on the list of persons present in the Zone may only move within the designated passage leading to the Zone and the ground-floor restroom. Unauthorized movement to other rooms or corridors of the F2 Student Dormitory is strictly prohibited. This restriction does not apply in the event of an evacuation.

4. The document authorizing access to the Zone is:

- 1) for residents of Student Dormitories F1 and F2 – a valid resident card;
- 2) for students and doctoral candidates of Bydgoszcz University of Science and Technology – a valid student ID;
- 3) for guests of student dormitory residents who are not students of Bydgoszcz University of Science and Technology – presentation of a valid photo ID at the reception;
- 4) for employees of Bydgoszcz University of Science and Technology – an official identification badge.

5. Student Dormitory administration staff and Reception staff are authorized to verify the status of individuals present in the Zone.

6. All individuals entering the Zone must sign the list of persons present in the Zone and collect a numbered card.

7. All individuals leaving the Zone must record their departure and return the numbered card.

8. The list of persons present in the Zone is kept at the Reception in building F2. Entry and exit from the Student Zone must be confirmed with a personal signature on the list.

9. A maximum of 50 people may be present in the Zone at any given time.

### § 3

1. The University Student Council may organize events in the Zone for a maximum of 50 participants.

2. A request to organize an event must be submitted to the administration at least two days before the planned date.

3. The request must include the event date and time, the estimated number of participants, and the name of the person responsible for the organization.

### § 4

1. The following activities are strictly prohibited in the Zone:

- 1) presence of individuals under the influence of alcohol or other intoxicating substances;
- 2) bringing in and consuming alcoholic beverages, using intoxicating substances, smoking cigarettes or electronic cigarettes;
- 3) bringing weapons or other sharp objects;
- 4) engaging in actions that endanger personal or public safety;
- 5) altering the interior design or damaging equipment;
- 6) using damaged equipment or attempting to repair it independently;

- 7) installing any additional devices without the approval of the building administrator;
- 8) using sound equipment that disrupts the peace of Student Dormitory residents;
- 9) organizing any private events or celebrations;
- 10) removing barcodes from the equipment.

2. Individuals using the Zone are also required to adhere to general principles and norms of social coexistence.

3. The person responsible for damage or destruction of the Zone's equipment and furnishings bears full financial liability for the incurred damages.

4. In cases of damage characterized as vandalism, the Student Dormitory Manager is obligated to notify the University Authorities, who will take appropriate actions in accordance with applicable legal provisions.

5. In justified cases, the Student Dormitory management—or, in their absence, a Reception staff member—may deny access to the Zone to individuals who have previously violated its rules, particularly regarding safety or order.

6. If an individual's behavior within the Recreation Zone violates its rules, endangers life or health, an administration or Reception staff member has the right to request that the individual leave the Zone.

7. The University is not responsible for private belongings left in the Zone or other publicly accessible areas.

## § 5

1. In the event of any irregularities or security violations, the Student Dormitory Administration, Reception staff, or relevant authorities must be notified immediately.

2. A first aid kit is located in the main hall (ground floor).

## § 6

In matters not regulated by this order regarding the use of the Zone, decisions shall be made on a case-by-case basis by the Rector of Bydgoszcz University of Science and Technology.
